### Terms of Reference for EOI: Thermostable live Newcastle disease virus vaccine (AAUPSD44C)

#### Purpose of the EoI:

Validation and Commercialization of the technology relating to production of a **Thermostable live Newcastle disease virus vaccine formulation (AAUPSD44C)** that has been recently developed under a DBT-funded project in the Department of Veterinary Microbiology, College of Veterinary Science, AAU, Khanapara, Guwahati.

#### Special Features of the **Thermostable live Newcastle disease virus vaccine formulation:**

1. The biologically active immunogen is a thermos-adapted lentogenic Newcastle disease virus isolate from duck.
2. Thermal stability of the immunogen is further increased by addition of a novel combination of excipients.
3. The thermostable live Newcastle disease virus vaccine formulation (AAUPSD44C) could retain haemagglutinin activity and infectivity of the biologically active immunogen at ambient temperature for extended period of time with optimum pellet profile.

#### Terms and Conditions:

1. The EoI submitted in the prescribed format only by eligible bidders will be considered.
2. The EoI is open ONLY to legal entities registered under the Indian Companies Act.
3. The applicant must have requisite expertise and experience of working in the livestock and poultry vaccine production sector.
4. Royalty charges (min 2.5%) and technology transfer fee will have to be paid by the selected applicant. The modalities for technology transfer fee will be fixed through mutual discussions.
5. The cost of necessary validation of the product prior to commercialization will be borne by the party expressing the interest.
6. The last date for submission of the EoI is 21-11-2022 by 16:30 Hrs.
7. No application will be accepted after the stipulated time and date of closure of the EoI, as mentioned above.
8. Selected party/parties will have to sign an MoU/Deed of Agreement with the AAU, Khanapara prior to transfer of technology relating to this product.
