



**12. Validity** (Both foreign & indigenous): Quoted rates must be valid for minimum 120 Days.

**13. Earnest Money** (Both foreign & indigenous):

All firms are required to submit Earnest Money along with the Quotation. The EMD of unsuccessful bidders shall be returned after award of contract. All tenders received without EMD shall be summarily rejected.

Refundable earnest money deposit, amounting to 2% for items of upto Rs 5,00,000.00 of the unit price of the quoted value of the equipments in the form of Demand draft to be

drawn in favour of DIRECTOR OF RESEARCH VETY payable at SBI Khanapara branch must be submitted along with the quotations.

**Earnest money deposit will not bear any interest, and have to be in the form of demand draft only**

14. Delivery of items at Instructional Poultry Farm (IPF), CVSc, Khanapara, Guwahati, will have to be maximum within 45(Forty-five) days from the date of issue of the Purchase Order.
15. **Mode of Payment:** After successful delivery of items at IPF, CVSc, AAU, Khanapara Guwahati-22, payment will be generally made through A/c payee cheque.
16. Late and delayed tender will not be considered. In case any unscheduled holiday occurs on prescribed closing the next working day shall be the prescribed date of closing.
17. No enquiry shall be made by the bidder(s) during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s). However, the Committee/its authorized representative and office of DR (VETY), AAU, KHANAPARA, GUWAHATI can make any enquiry/seek clarification from the bidders. 
