



ANNEXURE-I

TERMS AND CONDITIONS

1. In case the tender document is downloaded from the website, the bidder shall have to deposit **Rs. 200.00** (non refundable) in the form of Demand Draft drawn in favour of Dean, Faculty of Veterinary Science, AAU, Khanapara, Guwahati-22 as tender fee with the quotation.
2. The service provider should have valid registration/ license.
