

1. In case the tender document is downloaded from the website, the bidder shall have to deposit Rs. 200.00 (non refundable) in the form of Demand Draft drawn in favour of the Dean, Faculty of Veterinary Science, AAU, Khanapara, Guwahati-22 as tender fee with the quotation.
2. Space/ room will be provided by the Director of Clinics in the TVCC premises.
3. The base price for floating Expression of Interest (EOI) will be of Rs. 5000.00 (Rupees five thousand).
4. The room rent will have to be deposited per month in advance to the office of the Dean, Faculty of Veterinary Science, AAU, Khanapara, Guwahati-22.
